## Opportunities for Post-Graduation

### U.S. Fulbright Program Business Grants

Grants for U.S. citizens to pursue overseas graduate study, to serve as an English Teaching Assistant (ETA), or to conduct independent research projects. Several Fulbright awards are available in business. **Mexico:** Binational Business Internships; **Spain:** Instituto de Empresa Grants; **Finland:** Lappeenranta University of Technology Graduate Award; **Netherlands:** Erasmus University Rotterdam Award. Also, candidates can apply in business fields to any participating country to pursue projects of their own design.
