



What are Prestigious Fellowships?

Prestigious fellowships are nationally competitive merit-based awards providing funding opportunities to help students realize their goals. There are fellowships to fund study abroad; to fund professional development opportunities; to engage in the arts; to fund graduate school; and to do research. Applying for prestigious fellowships also creates an opportunity for self-reflection and critical thinking skill building.

Fellowships in International Business

There are many competitive fellowships that align with the goals of International Business majors. Examples are listed on the back. IB students should particularly seek fellowships that fund study abroad, overseas internships, foreign language study programs, and those offering professional development experiences.

- ❖ Offers a central purpose to building collaborative relationships with faculty and administrators as you seek out their advice, feedback and recommendation.

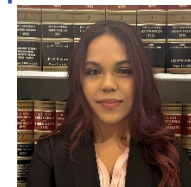

International Business Fellowships

Benjamin A. Gilman International Scholarship

International study is intended to better prepare U.S. students to assume significant roles in an increasingly global economy and interdependent world. With this goal in mind, Gilman annually offers 2,300 scholarships of up to \$5,000 for study abroad and international internships during winter, summer or fall/spring semesters.

Critical Language Scholarships

Fully-funded summer language institutes for U.S. university students. Provides intensive overseas study in the critical need foreign languages of Arabic, Azerbaijani, Bangla / Bengali, Chinese, Hindi, Indonesian, Japanese, Korean, Persian, Portuguese, Russian, Swahili, Turkish, and Urdu.

Boren Scholarships

Opportunities to study abroad in areas of the world that are critical to U.S. interests and underrepresented in study abroad. Focuses on geographic areas, languages, and fields of study deemed critical to U.S. national security.

Offers full funding for an 18-month vocational and language development experience in Taipei, Taiwan. Explore a variety of start-up industries in fields ranging from the cutting edge in FinTech, to supply chain management, and investment.

A cohort-based program providing 3 funded summer internships and opportunities to promising undergraduate students from NYC partner colleges. Harvard Summer Venture in Management

A funded one-week residential management training program for juniors and seniors designed to increase diversity and opportunity in business education and introduce students to Harvard's MBA experience.

Freeman-ASIA (Freeman Awards for Study in Asia)

Designed to support U.S.-based undergraduates with demonstrated financial need who are planning to study overseas in East or Southeast Asia. Increases the number of U.S. students with first-hand exposure to and understanding of Asia and its peoples and cultures.

Fully funded summer academic and cultural program for US citizen first and second year students. Participants explore the culture, heritage and history of the UK while experience higher education at a UK university.

Fulbright U.S. Student Program Business Grants

Grants for U.S. citizens to pursue overseas graduate study, to serve as an English Teaching Assistant (ETA), or to conduct independent research projects. Several Fulbright awards are available in business.

Mexico: Binational Business Internships; **UK:** UCL MSc in Entrepreneurship Award. **France:** CY Initiative Awards. **Spain:** IE Univ. Awards Grants; **Finland:** LUT Univ. Graduate Awards; **Netherlands:** Erasmus University Rotterdam Award. **Italy:** Luiss Award in Business. *Also, candidates can apply in business fields to any participating country to pursue projects of their own design.*

Congress-Bundestag Youth Exchange for Young Professionals

Participants spend a year studying and working while completely immersed in German culture. Covers 2 months German language training, semester of study at a German university, 5 month internship with a German company, accommodations, transatlantic airfare, monthly stipends, and insurance.

Serge Bellanger French-American Business Scholarships

Provides funding up to \$10,000 to US nationals who have been accepted to a MBA or business related Master's program in France, and to French nationals who will attend a U.S. based MBA program.

A one-year, fully-funded master's program in Global Affairs at Tsinghua University, designed to build a global community of future leaders who will serve to deepen understanding between China and the rest of the world. Open to citizens of any country.
